## A-B-E UNEMPLOYMENT RATE AT 3.7% IN FEBRUARY

HARRISBURG (APRIL 2) - The seasonally adjusted unemployment rate for the Allentown-Bethlehem-Easton, PA-NJ Metropolitan Statistical Area (MSA) was 3.7 percent in February, a decrease of one-tenth of a percentage point from January. The statewide rate was unchanged over the month at 3.4 percent while the national rate rose by two-tenths of a percentage point to 3.9 percent.

Note: Annual revisions to the historical (pre-2023) labor force series have not been completed and are not reflected in this news release. Historical labor force revisions are expected to be completed by the release of March data in late April 2024. Seasonally adjusted total nonfarm jobs in the A-B-E MSA were unchanged over the month, remaining at their record high of 395,000 in February. Over the year, jobs rose by 1.1 percent (+4,300) in the MSA, while statewide jobs increased by 1.2 percent. Detailed industry data for the MSA is not seasonally adjusted.

#### February's Not Seasonally Adjusted Nonfarm Jobs Detail (see Table 2)

Over the month, the largest employment gains were in education & health services (+2,100) and government (+700) due to the return from winter break at local schools, colleges, and universities. Over the year, six of the ten supersectors added jobs with the largest increase in education & health services, up 4,500 jobs.
